RESOLUTION NO. 23-410

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-82, 01-050, 04-**
17 **212, 04-291, 05-204, 05-711, 06-002, 07-075, 08-330, 09-066, 09-614, 10-001, and 10-**
18 **401 be amended to reflect the correct names of members identified in the**
19 **November 2023 Corrected Enrollment Resolution Summary, which is**
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 15-82, 01-050, 04-212, 04-291, 05-204, 05-711, 06-002, 07-075, 08-330, 09-066,**
23 **09-614, 10-001, and 10-401 are amended upon the effective date of those**
24 **resolutions to reflect the correct names of members identified in the November**
25 **2023 Corrected Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
27 **day of NOVEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
28 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**


