

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2024 Chukut Kuk District Budget Amendment No. 1 and FY  
2024 Chukut Kuk District Mining Royalties Budget Amendment No. 1)**

**RESOLUTION NO. 23-459**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2024 Chukut Kuk District Budget in the amount of \$2,792,116.12 was  
13 authorized by Chukut Kuk District Council Resolution No. 2023-25 and approved  
14 by Legislative Council Resolution No. 23-364; and

15 **WHEREAS** by Chukut Kuk District Council Resolution No. 2023-35, the Chukut Kuk District  
16 Council has authorized and submitted for review and approval its FY 2024 Chukut  
17 Kuk District Budget Amendment No. 1, which is incorporated by this reference  
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2024 Chukut Kuk District Budget Amendment No. 1 will increase the FY  
20 2024 Chukut Kuk District Budget by \$23,799.45 from \$2,792,116.12 to  
21 \$2,815,915.57; and

22 **WHEREAS,** the FY 2024 Chukut Kuk District Mining Royalties Budget in the amount of  
23 \$150,979.28 was authorized by Chukut Kuk District Council Resolution No. 2023-  
24 27 and approved by Legislative Council Resolution 23-430; and

25 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2023-35, the Chukut Kuk District  
26 Council has authorized and submitted for review and approval its FY 2024 Chukut  
27 Kuk District Mining Royalties Budget Amendment No. 1, which is incorporated by  
28 this reference and which will adjust operational and/or personnel line items; and

29 **WHEREAS,** the FY 2024 Chukut Kuk District Mining Royalties Budget Amendment No. 1 will  
30 increase the FY 2024 Chukut Kuk District Mining Royalties Budget by \$80,786.14  
31 from \$150,979.28 to \$231,765.42; and

1 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District**  
2 **Budget Amendment No. 1 and FY 2024 Chukut Kuk District Mining Royalties**  
3 **Budget Amendment No. 1 and recommends their approval.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
5 **FY 2024 Chukut Kuk Budget Amendment No. 1 effective October 1, 2023, which**  
6 **includes a \$23,799.45 increase from \$2,792,116.12 to \$2,815,915.57 that shall be**  
7 **funded as follows:**

- 8 (1) **FY 2023 carryover funds in the amount of \$22,499.25; and**  
9 (2) **FY 2014 mining royalties in the amount of \$886.15; and**  
10 (3) **FY 2016 mining royalties in the amount of \$414.05.**

11 **NOW, THEREFORE, BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council**  
12 **approves the FY 2024 Mining Royalties Budget Amendment No. 1 effective October**  
13 **1, 2023, which includes an \$80,786.14 increase from \$150,979.28 to \$231,765.42**  
14 **that shall be funded as follows:**

- 15 (1) **FY 2020 mining royalties in the amount of \$31,779.43; and**  
16 (2) **FY 2023 mining royalties in the amount of \$49,006.71.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024 Chukut**  
18 **Kuk District Budget and FY 2024 Chukut Kuk District Mining Royalties Budget**  
19 **shall be managed and expended in accordance with Article IX, Section 7 of the**  
20 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**  
21 **any amendments or modifications shall be authorized under District Council**  
22 **resolution and submitted for prior approval by the Tohono O'odham Legislative**  
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
25 **day of DECEMBER 2023 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**  
26 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
30 **(48 Stat.984).**
