

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Department of Health and Human Services, Executive
Director Budget Amendment No. 1)**

RESOLUTION NO. 24-010

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2024 Department of Health and Human Services, Executive Director**
8 **Budget in the amount of \$308,941.86 was approved by Resolution No. 23-192; and**

9 **WHEREAS, the Department of Health and Human Services, Office of the Executive Director**
10 **prepared and submitted for review and approval its FY 2024 Budget Amendment**
11 **No. 1, which is incorporated by this reference, that will adjust operational line**
12 **items, and which will not change the original budget amount; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2024 Department of Health and Human Services, Executive**
15 **Director Budget Amendment No. 1 and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2024 Department of Health and Human Services, Executive Director Budget**
18 **Amendment No.1 effective October 1, 2023, in the amount of \$308,941.86 that shall**
19 **be funded by the Nation's General Fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2024 Department of Health and Human Services, Executive**
23 **Director Budget as amended, provided however, that any amendments or**
24 **modifications shall be submitted for prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
27 **day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
