

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Tohono O'odham Gaming Office, Budget Amendment No. 1)**

RESOLUTION NO. 24-018

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Tohono O'odham Gaming Office Budget in the amount of
8 \$12,573,388.66 was approved by Resolution No. 23-192; and

9 **WHEREAS,** the Tohono O'odham Gaming Office has prepared and submitted for review and
10 approval its FY2024 Tohono O'odham Gaming Office Budget Amendment No.1,
11 which is incorporated by this reference, and which will adjust operational and
12 personnel line items; and

13 **WHEREAS,** the FY2024 Tohono O'odham Gaming Office Budget Amendment No. 1 will
14 increase the FY2024 Tohono O'odham Gaming Office Budget by \$4,996,280.31
15 from \$12,573,388.66 to \$17,569,668.97; and

16 **WHEREAS,** the Commerce and Budget and Finance Committees have reviewed the FY 2024
17 Tohono O'odham Gaming Office Budget Amendment No. 1 and recommend its
18 approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2024 Tohono O'odham Gaming Office Budget Amendment No. 1 (effective
21 October 1, 2023), which includes a \$4,996,280.31 increase from \$12,573,388.66 to
22 \$17,569,668.97 that shall be funded by the Nation's general fund.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2024 Tohono O'odham Gaming Office Budget Amendment No. 1 as
26 amended, provided that any amendments or modifications shall be submitted
27 for prior approval by the Tohono O'odham Legislative Council.

28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17th
29 day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.30 FOR;
30 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
31 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
32 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
33 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
34 18, 1934 (48 Stat.984).
