

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting January 31, 2024 Closed Special Session for an Audit Presentation)**

**LEGISLATIVE ORDER NO. 24-026**

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and


5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vest the Council  
6 with the authority to "by majority vote, call for a special session" (Legislative  
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 **WHEREAS,** the Budget and Finance Committee has requested a closed special session on  
9 January 31, 2024 beginning at 10:00 a.m. for an audit presentation.

10 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a  
11 closed special session on January 31, 2024 beginning at 10:00 a.m. for an audit  
12 presentation.


13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> day of

15 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
16 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the  
17 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
19 18, 1934 (48 Stat.984).
