

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Information & Technology Budget Amendment No. 1)**

RESOLUTION NO. 24-027

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2024 Department of Information & Technology Budget was approved by**
8 **Resolution No. 23-192 in the amount of \$4,735,749.91; and**

9 **WHEREAS, the Department of Information & Technology has prepared and submitted for**
10 **review and approval its FY 2024 Budget Amendment No.1, which is incorporated**
11 **by this reference, and which will adjust operational and/or personnel line items;**
12 **and**

13 **WHEREAS, the FY 2024 Department of Information & Technology Budget Amendment No.1**
14 **will not change the amount of the original budget; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024 Department of**
16 **Information & Technology Budget Amendment No.1 and recommends approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2024 Department of Information & Technology Budget Amendment No.1,**
19 **effective October 1, 2023, which will be funded by the Nation's general fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2024 Department of Information & Technology Budget as**
23 **amended, provided that any further amendments or modifications shall be**
24 **submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17th**
26 **day of JANUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
