7	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
8		within the exclusive control of the Tohono O'odham Nation and to appropriate
9		these funds for the benefit of the Nation and its members" provided that "[all
10		expenditures of these funds shall be pursuant to appropriations or budgets"
11		anthorized by resolution or ordinance (Constitution of the Tohono O'odham
12		Nation, Article VI, Section I(d)(2)); and
13	WHEREAS,	in November 2023, Legislative Council passed Resolution No. 23-440 to approve
14		the Transferring Sif Oidak District Financial Management Functions and Control
15		of Funds to the Tohono O'odham Nation; and
16	WHEREAS,	the Tohono O'odham Nation received an Add-on Services Order Form and "Terms
17		and Conditions" thereto to add on payroll and 401k configuration into the
18		Nation's existing iSolved, Inc. system in the amount of \$3,300 to support Sif Oidak
19		Districts payroll and 401k processing; and
20	WHEREAS,	it is necessary to such financial management function and control of the Sif Oidak
21		District to perform HR, payroll, ACA compliance, Open Enrollment and Benefits
22		cost analysis, W2 Production fees, 1094/1095 C Production fees, ("Services") and
23		the iSolved "Initial or Add-on Services Order Form" and the "Terms and
24		Conditions" incorporated therein provide those necessary Services to
25		accomplish such financial management to carry out Resolution No. 23-440; and
26	WHEREAS,	iSolved Terms and Conditions Agreement ("Agreement"), contains certain terms
27		and conditions that require the Nation to grant a limited waiver of its sovereign
28		immunity to iSolved, Inc. to indemnify iSolved, Inc. under the circumstances

as such, the Tohono O'odham Nation, through its Department of Information and 1 WHEREAS, 2 Technology, submits for review and approval the Agreement and requests a 3 limited waiver of the Nation's sovereign immunity under the following 4 conditions: 5 "Limited Waiver of Sovereign Immunity and Governing Law. [The Nation] hereby 6 provides a limited waiver of sovereign immunity for the purpose of resolving any 7 dispute that arises out of this Agreement. Nothing in this limited waiver shall be 8 deemed to waive the Nation's immunity from suit except as to a case/claim 9 brought by iSolved, Inc. alleging breach of this Agreement. Pursuant to the 10 Agreement the governing law shall be Delaware and venue and jurisdiction for 11 any such claim shall be in the federal court in the state of North Carolina. [The 12 Nation's Attorney General is authorized to accept service on behalf of [the 13 Nation]." the Agreement also requires the Nation to indemnify iSolved for any breach of the 14 WHEREAS. 15

- Agreement or breach of applicable law by the Nation; and
- it is in the best interests of the Nation to effectuate efficient and expeditious WHEREAS. management of the Sif Oidak District that any renewal, extension, or expansion of services that contain the same "Terms and Conditions" as in the Agreement is also approved without need for a further resolution by the Tohono O'odbam Legislative Council ("Renewal"); and
- the Budget and Finance Committee of the Legislative Conncil has reviewed the WHEREAS, Agreement, including exhibits, between iSolved, Inc. and the Tohono O'odham Nation and recommends its approval.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and authorizes a limited waiver of the Nation's sovereign immunity and approves the indemnification in favor of iSolved, Inc., under the specific conditions described
- BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to execute the agreement with iSolved, Inc, and any Renewal thereof, substantially in the same form attached bereto.
