

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2025 Department of Health and Human Services Healthy O'odham
Promotion Program Budget)**

RESOLUTION NO. 24-029

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2025 Healthy O'odham Promotion Program Budget,
9 which is incorporated by this reference, in the amount of \$2,241,130.00, which
10 shall be funded by the Nation's general fund pending reimbursement from the
11 grantor the Indian Health Service Special Diabetes Program for Indians; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have reviewed
13 the FY 2025 Department of Health and Human Services Healthy O'odham
14 Promotion Program Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council:

16 (1) approves the FY 2025 DHHS Healthy O'odham Promotion Program Budget
17 effective January 1, 2024 through December 31, 2024 in the amount of
18 \$2,241,130.00, which shall be funded by the Nation's general fund pending
19 reimbursement from the grantor, the Indian Health Service Special
20 Diabetes Program for Indians; and

21 (2) directs, that in the event the federal government does not approve a FY
22 2024 federal funding appropriations bill, the Department of Health and
23 Human Services Healthy O'odham Promotion Program to limit spending
24 to only essential program services, functions, and activities up to the
25 amount awarded by the federal government; and the Nation shall seek
26 reimbursement of all funds the Nation expends for continuation of the
27 services performed pursuant to the FY 2025 Department of Health and
28 Human Services Healthy O'odham Promotion Program Budget.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
30 Nation chairperson or any designated official is authorized to administer and
31 expend the FY 2025 Department of Health and Human Services Healthy O'odham
