

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Health and Human Services Division of Health  
Transportation Services Budget Amendment No. 1)**

**RESOLUTION NO. 24-030**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services Division of Health  
8 Transportation Services Budget in the amount of \$3,987,363.45 was approved by  
9 Legislative Council Resolution No. 23-192; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2024 Department of Health and Human Services  
12 Division of Health Transportation Services Budget Amendment No. 1, which is  
13 incorporated by this reference, and which will adjust personnel line items but  
14 will not change the overall budget amount of \$3,987,363.45; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
16 reviewed the FY 2024 Department of Health and Human Services Division of  
17 Health Transportation Services Budget Amendment No. 1 and recommend its  
18 approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 FY 2024 Department of Health and Human Services Division of Health  
21 Transportation Services Budget Amendment No. 1, retroactively effective to  
22 October 1, 2023, which will not change the budget amount of \$3,987,363.45 that  
23 shall be funded by the Nation's General Fund.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2024 Department of Health and Human Services Division of Health  
27 Transportation Services Budget as amended, provided that any amendments or  
28 modifications shall be submitted for prior approval by the Tohono O'odham  
29 Legislative Council.






