RESOLUTION NO. 24-036

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Constitution**
3 **of the Tohono O'odham Nation, Article II, Sections 1 and 2 and Article VI, Section**
4 **1(h)); and**

5 **WHEREAS, pursuant to Articles VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a written**
7 **recommendation to the Tohono O'odham Legislative Council to approve or reject**
8 **the application (14 Tohono O'odham Code Chapter 1 - Enrollment Ordinance);**
9 **and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**


13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal name**
14 **changes of enrolled members as a result of marriage, divorce, legal adoption, or**
15 **for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 05-368, 07-706, and**
17 **18-220 be amended to reflect the legal name changes of members identified in the**
18 **February 2024 Amended Enrollment Resolution Summary, which is incorporated**
19 **by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
21 **that Resolution Nos. 05-368, 07-706, and 18-220 are amended upon the effective**
22 **date of those resolutions to reflect the legal name changes of members identified**
23 **in the February 2024 Amended Enrollment Resolution Summary.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
25 **day of FEBRUARY 2024 at a meeting at which a quorum was present with a vote of 3,263.3**
26 **FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
27 **Council by Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the**
28 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
29 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
30 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






