

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Department of Health and Human Services, Division of Adult Protection Services Budget Amendment No. 1)

RESOLUTION NO. 24-044

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services, Division of Adult
8 Protection Services Budget in the amount of \$1,348,178.83 was approved by
9 Resolution No. 23-192; and

10 **WHEREAS,** the Department of Health and Human Services, Division of Adult Protection
11 Services has prepared and submitted for review and approval its FY 2024 Budget
12 Amendment No. 1, which is incorporated by this reference, and which will adjust
13 operational line items, and which will not change the overall budget amount; and

14 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
15 reviewed the FY 2024 Department of Health and Human Services, Division of
16 Adult Protection Services Amendment No. 1 and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
18 the FY 2024 Department of Health and Human Services, Division of Adult
19 Protection Services Budget Amendment No.1 effective October 1, 2023, in the
20 amount of \$1,348,178.83 that shall be funded by the Nation's General Fund.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
22 O'odham Nation chairperson or any designated official is authorized to administer
23 and expend the FY 2024 Department of Health and Human Services, Division of
24 Adult Protection Services Budget as amended, provided that any amendments or
25 modifications shall be submitted for prior approval by the Tohono O'odham
26 Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
28 day of **FEBRUARY 2024** at a meeting at which a quorum was present with a vote of **2,624.6**
29 **FOR; -0- AGAINST; -0- NOT VOTING; and 638.7 [07] ABSENT**, pursuant to the powers vested
30 in the Council by Article VI, Section 1(d)(2) and (2) of the Constitution of the Tohono O'odham
31 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
32 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
33 16 of the Act of June 18, 1934 (48 Stat.984).


