

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2024 Department of Health and Human Services Division of
Senior Services Title VI Part C American Rescue Plan Budget Amendment No. 2)**

RESOLUTION NO. 24-047

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Health and Human Services, Division of Senior
8 Services Title VI Part C American Rescue Plan Budget in the amount of
9 \$55,340.00 was approved by Resolution No. 21-464 and later amended by
10 Resolution No. 22-149; and

11 **WHEREAS,** the Department of Health and Human Services, Division of Senior Services has
12 prepared and submitted for review and approval its FY 2024 Title VI Part C
13 American Rescue Plan Budget Amendment No. 2, which is incorporated by this
14 reference, and which will adjust operational line items but will not change the
15 overall budget amount of \$55,340.00; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2024 Department of Health and Human Services Division of
18 Senior Services Title VI Part C American Rescue Plan Budget Amendment No. 2
19 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
21 the FY 2024 Department of Health and Human Services Division of Senior
22 Services Title VI Part C American Rescue Plan Budget Amendment No.2, effective
23 May 1, 2021, in the amount of \$55,340.00 which shall be funded by the Nation's
24 general fund pending reimbursement from the grantor, the United States
25 Department of Health and Human Services Administration for Community Living.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
27 O'odham Nation chairperson or any designated official is authorized to administer
28 and expend the FY 2024 Department of Health and Human Services, Division of
29 Senior Services Title VI Part C American Rescue Plan Budget as amended,
30 provided that any amendments or modifications shall be submitted for prior
31 approval by the Tohono O'odham Legislative Council.


