9	WHEREAS,	the Department of Health and Human Services has prepared and submitted for
10		review and approval its FY 2024 Behavioral Health Budget Amendment No. 1,
11		which is incorporated by this reference, which increases the budget from
12		\$2,998,037.32 to \$3,405,290.37, for a total increase of \$407,253.05; and
13	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
14		reviewed the FY 2024 Department of Health and Human Services Behavioral
15		Health Budget Amendment No. 1 and recommend its approval.
16	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
17		the FY 2024 Department of Health and Human Services Bebavioral Health Budget
18		Amendment No. 1 effective October 1, 2023, which increases the budget by
19		\$407,253.05, from \$2,998,037.32 to \$3,405,290.37, which shall be funded by the
20		Self-Governance Funding Agreement.
