

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Tohono O'odham Nation Health Care Budget Amendments)**

RESOLUTION NO. 24-061

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of
8 \$143,752,787.99 was approved by Resolution No. 23-191; and

9 **WHEREAS,** the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of
10 \$144,874,503.15 were amended by Resolution No. 23-406; and

11 **WHEREAS,** the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of
12 \$145,512,874.53 were amended by Resolution No. 23-432; and

13 **WHEREAS,** the FY 2024 Tohono O'odham Nation Health Care Budgets in the amount of
14 \$145,617,726.20 were amended by Resolution No. 24-019; and

15 **WHEREAS,** Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted for
16 review and approval budget amendments to the FY 2024 Tohono O'odham Nation
17 Health Care Budgets, as detailed below, which are incorporated by this reference,
18 and which identify the budget being amended along with their total amounts as
19 follows:






