(Recognition of Relinquishment from membership in the Tohono O'odham Nation for the month of March 2024)

RESOLUTION NO. 24-070

- WHEREAS, Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative Council with the power to "enact laws and ordinances governing the enrollment and adoption of members and the relinquishment and loss of membership"; and
- WHEREAS, in accordance with the Tohono O'odham Nation's Enrollment Ordinance, Ordinance No. 05-81 as amended the Enrollment Committee has received a written statement from <u>01</u> tribal member who has expressed their intent to relinquish their membership with the Tohono O'odham Nation and the members are identified in the March 2024 Relinquishment List, which is incorporated by this reference; and
- WHEREAS, pursuant to Article IX Section 1 of the Enrollment Ordinance,

A member of the Nation may relinquish his membership in the Nation by submitting a written statement clearly expressing an intent to relinquish his membership to the Council, a copy of which must be served on the committee. The written statement must be signed by the person wishing to relinquish his membership or, if a minor or incompetent, by the parent(s), guardian or other person legally authorized to act on his behalf. Relinquishment does not require the approval of the Council, but is effective upon receipt of the statement by the Council and cannot be subsequently denied. Upon recognition by the Council that the individual has renounced his membership, his name shall be deleted from the membership roll.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby recognizes that the one individual identified in the March 2024 Relinquishment List have relinquished their membership in the Tohono O'odham Nation and orders the removal of their names from the Nation's membership roll.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>04TH</u> day of <u>MARCH 2024</u> at a meeting at which a quorum was present with a vote of <u>3,263.3</u> FOR; <u>-0-</u> AGAINST; <u>[01]</u> NOT VOTING; and <u>-0-</u> ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
