

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Gu-Vo District Kukatch Community Budget)**

RESOLUTION NO. 24-081

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-24-018, the Gu-Vo District has
13 authorized the FY 2024 Kukatch Community Budget, which is incorporated by
14 this reference, in the amount of \$31,446.64; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Gu-Vo District
16 Kukatch Community Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
18 the FY 2024 Gu-Vo District Kukatch Community Budget effective October 1, 2023
19 in the amount of \$31,446.64, which shall be funded by proceeds from insurance
20 claims for Kukatch Community.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2024 Gu-
22 Vo District Kukatch Community Budget shall be managed and expended in
23 accordance with Article IX, Section 7, of the Constitution of the Tohono O'odham
24 Nation and the Nation's laws, provided that any amendments or modifications
25 shall be authorized under District Council resolution and submitted for prior
26 approval by the Tohono Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
28 day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR;
29 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council
30 by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the
31 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
33 June 18, 1934 (48 Stat.984).
