

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Tohono O'odham Nation 2024 Indian Housing Plan)**

**RESOLUTION NO. 24-082**

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with  
2 the power to enact laws "to promote, protect and provide for public health, peace,  
3 morals, education and general welfare of the Tohono O'odham Nation and its  
4 members" (Constitution, Article VI, Section 1(c)(2)); and

5 **WHEREAS,** the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally  
6 designated housing entity in accordance with the Native American Housing  
7 Assistance and Self-Determination Act of 1996, 25 U.S.C §4101, et seq., P.L. 104-  
8 330, 110 Stat. 4016 ("NAHASDA"); and

9 **WHEREAS,** to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA  
10 requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe  
11 or by the tribe's designated housing entity (25 U.S.C §4112); and

12 **WHEREAS,** pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,  
13 Chapter 1, the TOKA shall submit annually to the United States Department of  
14 Housing and Urban Development's Southwest Area Office of Native American  
15 Programs ("SWONAP") the Nation's Indian Housing Plan after review and  
16 approval by Legislative Council resolution (TOKA Ordinance, Article IX, 1.,  
17 <https://www.tolc-nsn.gov/docs/Title18Ch1.pdf>); and

18 **WHEREAS,** under the direction of the TOKA's executive director, the TOKA prepared and  
19 submitted the Nation's 2024 Indian Housing Plan for the program year beginning  
20 July 1, 2024 and ending June 30, 2025 to TOKA's Board of Directors for review  
21 and approval (TOKA Ordinance, Article IX, 1, b., ii.); and

22 **WHEREAS,** after approving the Nation's 2024 Indian Housing Plan by Resolution No. 02-03-  
23 24, the TOKA's Board of Directors provided the IHP to the Legislative Housing  
24 Committee for review and approval (TOKA Ordinance, Article IX, 1, b., iii.); and

25 **WHEREAS,** the Legislative Housing Committee reviewed and recommends approval of the  
26 Nation's 2024 Indian Housing Plan for the program year beginning July 1, 2024  
27 and ending June 30, 2025.

28 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that it  
29 approves the Nation's 2024 Indian Housing Plan, provided that any amendments  
30 are subject to Legislative Council review and approval.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the Nation's chairperson to sign the certification authorizing submission by the TOKA of the Nation's 2024 Indian Housing Plan.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,005.7 FOR; -0- AGAINST; 257.6 [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


