

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Chukut Kuk District Budget Amendment No. 2)**

RESOLUTION NO. 24-087

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** the FY 2024 Chukut Kuk District Budget in the amount of \$2,792,116.12 was
13 authorized by Chukut Kuk District Council Resolution No. 2023-25 and approved
14 by Legislative Council Resolution No. 23-364, and subsequently amended by
15 Legislative Council Resolution No. 23-459; and

16 **WHEREAS** by Chukut Kuk District Council Resolution No. 2024-02, the Chukut Kuk District
17 Council has authorized and submitted for review and approval its FY 2024 Chukut
18 Kuk District Budget Amendment No. 2, which is incorporated by this reference
19 and which will adjust operational and/or personnel line items; and

20 **WHEREAS,** the FY 2024 Chukut Kuk District Budget Amendment No. 2 will increase the
21 overall FY 2024 Chukut Kuk District Budget by \$4,010.51 from \$2,815,915.57
22 to \$2,819,926.08; and

23 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2024 Chukut Kuk District
24 Budget Amendment No. 2 and recommends its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
26 the FY 2024 Chukut Kuk District Budget Amendment No. 2 effective October 1,
27 2023, which includes a \$4,010.51 increase from \$2,815,915.57 to \$2,819,926.08,
28 which shall be funded as follows:

- 29 **(1) FY 2015 carryover funds in the amount of \$8.16; and**
30 **(2) FY 2016 carryover funds in the amount of \$4,002.35.**

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2024
32 Chukut Kuk District Budget shall be managed and expended in accordance with
33 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the

Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3,263.3 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


