

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agreement to Re-Adopt and Extend Intergovernmental Agreement Between
Tohono O'odham Nation on Behalf of the Tohono O'odham Police Department and
the Arizona State Department of Public Safety)

RESOLUTION NO. 24-089

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to "promote,
2 protect and provide for public health, peace, morals, education and general welfare
3 of the Tohono O'odham Nation and its members" and to "consult, negotiate and
4 conclude agreements . . . on behalf of the Tohono O'odham Nation with Federal,
5 State and local governments and other Indian tribes or their departments,
6 agencies, or political subdivisions . . . on all matters within the authority of the
7 Tohono O'odham Council" (Constitution of the Tohono O'odham Nation, Article
8 VI, Sections 1(c)(2) and (f)); and

9 **WHEREAS,** the Tohono O'odham Nation entered into an Intergovernmental Agreement
10 Between Tohono O'odham Nation on Behalf of the Tohono O'odham Police
11 Department and the Arizona State Department of Public Safety (the
12 "Intergovernmental Agreement") approved by Resolution No. 19-181 and
13 amended by Resolution No. 19-428; and

14 **WHEREAS,** the Tohono O'odham Nation desires to readopt and extend the Intergovernmental
15 Agreement; and

16 **WHEREAS,** the fees to be paid to the Arizona Department of Public Safety pursuant to the
17 Intergovernmental Agreement will be funded by the FY 2024 Department of
18 Public Safety Tohono O'odham Nation Police Department Budget; and

19 **WHEREAS,** the Domestic Affairs Committee has reviewed the Agreement to Re-Adopt and
20 Extend the Intergovernmental Agreement Between Tohono O'odham Nation on
21 Behalf of the Tohono O'odham Police Department and the Arizona State
22 Department of Public Safety and recommends its approval; and

23 **WHEREAS,** the Agreement to Re-Adopt and Extend the Intergovernmental Agreement will be
24 effective as of January 1, 2024 and will continue through December 31, 2024.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
26 the Agreement to Re-Adopt and Extend the Intergovernmental Agreement Between
27 Tohono O'odham Nation on Behalf of the Tohono O'odham Police Department
28 and the Arizona State Department of Public Safety.

29 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that nothing in this
30 Resolution or the Intergovernmental Agreement shall be interpreted as a waiver
31 of the Nation's sovereign immunity in any forum or in any jurisdiction.



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
2 O'odham Nation Chairperson is authorized to execute the Agreement to Re-Adopt
3 and Extend the Intergovernmental Agreement Between Tohono O'odham Nation
4 on Behalf of the Tohono O'odham Police Department and the Arizona State
5 Department of Public Safety substantially in the form attached hereto provided
6 that any amendments shall be submitted for prior approval by the Tohono
7 O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH
9 day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3.263.3 FOR;
10 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council
11 by Article VI, Sections 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted
12 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
14 the Act of June 18, 1934 (48 Stat.984).




