

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021-2024 Gu-Vo District American Rescue Plan Act)**

RESOLUTION NO. 24-093

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-24-014, the Gu-Vo District has
13 **authorized the FY 2021-2024 Gu-Vo District American Rescue Plan Act ("ARPA")**
14 **Budget, which is incorporated by this reference, in the amount of \$3,470,710.00;**
15 **and**

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021-2024 Gu-Vo District
17 **ARPA Budget and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Nation Legislative Council
19 **approves the FY 2021-2024 Gu-Vo District ARPA Budget in the amount of**
20 **\$3,470,710.00 effective March 11, 2021 through December 31, 2024, which shall be**
21 **funded by the Tohono O'odham Nation Rescue Plan Act funds pursuant to**
22 **Resolution No. 21-292.**

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021-2024 Gu-
24 **Vo District American Rescue Plan Act Budget shall be managed and expended in**
25 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
26 **Nation and the Nation's Laws, provided that any amendments or modifications**
27 **shall be authorized under District Council resolution and submitted for prior**
28 **approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH day of MARCH 2024 at a meeting at which a quorum was present with a vote of 3.027.1 FOR; -0- AGAINST; -0- NOT VOTING; and 236.2[03] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


