9	WHEREAS,	pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono
10		O'odham Legislative Council shall determine eligibility for membership or
11		adoption; and
12	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
13		membership and adoption applications misspelled or incorrectly listed the
14		names and/or dates of birth of members; and
15	WHEREAS,	the Enrollment Committee recommends that Resolution Nos. 06-449, 06-511,
16		06-578, 06-787, 07-007, 07-075, 07-112, 10-020, and 12-085 be amended to reflect
17		the correct name and/or date of birth of the members identified in the April 2024
18		Corrected Enrollment Resolution Summary, which is incorporated by this
19		reference.
