

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024-FY 2025 Pisinemo District San Simon Community Mining  
Royalty Multi-Year Budget)**

**RESOLUTION NO. 24-126**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, by Pisinemo District Council Resolution No. 24-P-13 the Pisinemo District has**  
13 **authorized the FY 2024-FY 2025 San Simon Community Mining Royalties Multi-**  
14 **Year Budget, which is incorporated by this reference, in the amount of \$44,846.07;**  
15 **and**

16 **WHEREAS, the FY 2023 District Mining Royalties allocation in the amount of \$179,691.35 was**  
17 **authorized by Legislative Council Resolution No. 23-280; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2024-FY 2025 Pisinemo**  
19 **District San Simon Community Mining Royalty Multi-Year Budget and**  
20 **recommends its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2024-FY 2025 Pisinemo District San Simon Community Mining Royalty Multi-**  
23 **Year Budget effective October 1, 2023 through September 30, 2025 in the amount**  
24 **of \$44,846.07, which shall be funded as follows:**

25 **(1) Pisinemo District Royalty funds in the amount of \$29,948.56; and**

26 **(2) FY 2023 Mining Royalties carryover funds in the amount of \$14,897.51.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2024-FY 2025**  
28 **Pisinemo District San Simon Community Mining Royalty Multi-Year Budget shall**  
29 **be managed and expended in accordance with Article IX, Section 7 of the**  
30 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**  
31 **any amendments or modifications shall be authorized under District Council**
