**RESOLUTION NO. 24-162**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**  
14 **name changes of enrolled members as a result of marriage, divorce, legal**  
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-80, 629-85, 215**  
17 **88, 303-88, 98-429, 01-449, 03-100, 06-002, 06-222, 07-112, 07-739, 09-008, 09-167,**  
18 **10-439, 13-391 and 19-445 be amended to reflect the legal names changes of**  
19 **members identified in the June 2024 Amended Enrollment Resolution Summary,**  
20 **which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 15-80, 629-85, 215-88, 303-88, 98-429, 01-449, 03-100, 06-002, 06-222, 07-112,**  
23 **07-739, 09-008, 09-167, 10-439, 13-391 and 19-445 are amended upon the effective**  
24 **date of those resolutions to reflect the legal name changes of members identified**  
25 **in the June 2024 Amended Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
27 **day of JUNE 2024 at a meeting at which a quorum was present with a vote of 3,042.8 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and 220.5 [03] ABSENT, pursuant to the powers vested in the Council**  
29 **by Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
30 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**  
31 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
32 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
