

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Education Tohono O'odham  
ha Ma:mscama i he We:mta Budget Amendment No. 1)**

**RESOLUTION NO. 24-166**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2024 Department of Education Tohono O'odham ha Ma:mscama i he  
8 We:mta Budget in the amount of \$627,568.51 was approved by Resolution No. 23-  
9 192; and

10 **WHEREAS,** the Department of Education has prepared and submitted for review and  
11 approval its FY 2024 Tohono O'odham ha Ma:mscama i he We:mta Budget  
12 Amendment No. 1, which is incorporated by this reference and which will create  
13 and adjust operational line items; and

14 **WHEREAS,** the FY 2024 Tohono O'odham ha Ma:mscama i he We:mta Budget Amendment No.  
15 1 will not change the 2024 Tohono O'odham ha Ma:mscama i he We:mta Budget  
16 amount of \$627,568.51; and

17 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
18 reviewed the FY 2024 Department of Education Tohono O'odham ha Ma:mscama  
19 i he We:mta Budget Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2024 Department of Education Tohono O'odham ha Ma:mscama i he We:mta  
22 Budget Amendment No. 1 effective October 1, 2023, which does not change the  
23 2024 Tohono O'odham ha Ma:mscama i he We:mta Budget amount of \$627,568.51.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2024 Department of Education Tohono O'odham ha Ma:mscama i  
27 he We:mta Budget as amended, provided that any amendments or modifications  
28 shall be submitted for prior approval by the Tohono O'odham Legislative Council.
