I am providing notice that based upon the steady increase of daily rates of COVID-19, the Legislative Branch modular and administrative offices will remain closed through January 31, 2021, at which time conditions will be reassessed. The Legislative Branch is committed to continuing essential Branch operations to the extent possible in accordance with the Legislative Branch COVID-19 Pandemic Response Plan while also supporting measures to mitigate the spread of COVID-19.
