CHAPTER 2 – RODEO AND FAIR

Legislative History: Ordinance No. 4, establishing the Rodeo and Fair Association, was enacted by the Papago Council on January 7, 1939 and approved by the Sells Indian Agency Superintendent on January 7, 1939; amended by Resolution No. 37-79, which was enacted by the Papago Council on May 11, 1979.

Related Legislation: Resolution No. 98-026, "Authorization for Use of Proceeds and Revenues Derived from the Nation's Annual Rodeo and Fair," was approved January 26, 1998.

ORDINANCE OF THE PAPAGO COUNCIL

No. 4

An ordinance to authorize an association for the purpose of holding an annual fair, livestock show, and rodeo at Sells Agency; to provide for the government of said association, and for other purposes.

Be it enacted by the Papago council in regular meeting on January 7, 1937:

Section No. 1 NAME OF ASSOCIATION: There is hereby authorized an organization composed of the Papago Tribe to be known as "The Papago Fair and Rodeo Association", here-

after referred to as the association.

Section No. 2 MANAGEMENT: The 'affairs of the association shall be managed by a Board of Directors, composed of five members of the tribe, who shall be appointed by the Papago Council to serve during good behavior. Immediatley after appointment, the Board of Directors shall proceed to elect from within its membership, a chairman, a secretary, and treasurer.

SEction No. 3 POWER AND DUTIES OF THE BOARD OF DIRECTORS

- (A) Fix the opening and closing dated for each annual "Papago Fair, Livestock Show, and Rodeo"
- (B) Establish suitabal departments in the fair, livestock show and rodeo as needed, to insure orderly growth and progress and appoint personnel to supervise the work of the several departments, provided; that in the event it is desired to utilized the services of regular personnel, the approval of the superintendent shall first be obtained.
- (C) Prepare an annual budget of funds requires to carry on the work of the Association not less than 90 days prior to the opening date of the Fair.
- (D) Fix admission hearges, control the sale of concessions, and determine the general policy of the Association.
- (E) Select permanent grounds suitable for housing and holding all departments of the Association contiguously, and plan and make recommendations for construction of

- (E) adequate facilities for carrying on the work of the assocation and to have custody of all such facilities.
- (F) To approve all expenditures from the treasury of the Association prior to disbursement by the treasurer.
- (G) To make such other rules and regulations, consistent with existing applicable law and regulations, as maybe necessary for the proper functioning of the Association
- (H) To contract for and operate legal amusement devices to assist in makeing the Association self-supporting.

Section No. 4 DUTIES OF ASSOCIATION OFFICERS

- (A) The Chairman, when present, shall preside at meetings of the Board and shall vote only in case of a tie.
- (B) The secretary shall keep the minutes of all meetings of the Board of Directors, conduct all Association coresspondence and keep an accurate record of all business trasacted..
- (C) The treasurer of the Papago Fair and Rodeo Association shall accept, receipt, for, Keep, and safeguard all funds of the Association. He shall deposit all such funds in the name of the Association, subject to his checking account, in a bank insured by the Federal Deposit Insuarance Corporation, and located in Tucson, Arizona, to be selected by the Board of Directors and shall make and preserve a faithful record of such funds and shall report on all receipts and expenditures and the amount and nature of all funds in his possession or custody, to the Board of Directors of the Association, at meetings of the Board, or at such other times as request by the Board, his reports to be in writing an matters of record. He shall give a satisfactory surety bond ot the Association in the sum of \$2,000.00 and shall not pay or other wise disburse any funds in the possession or custody of the Papago Fair and Rodeo Association except when

- (C) properly authorized to do so by resolution duly passed by the Board of Directors of the Assocaition.
- (D) The books and records of the treasurer of the Association shall be audited at least ones a year by a competent auditor employed by the Papago Council, and at such other times as the Papago Council, the Bdard of Driectors of the Association, or the Commissioner of Indian Affairs may directs.

Section No. 5 MEETINGS

Meetings of the Board of Directors of the Association shall be held on call of the Chairman, or by mutual affirment of 4 quorum.

No business shall be transacted by the Baord of Directors unless a quorum is present. A quorum shall consist of a majority of the Board of Directors

Section No. 6 AMENDEMENT OF ORDINANCE NO. 3

Ordinance No. 3, approved April 3, 1938, is hereby amended to permit the Board of Directors of the Papago Fair and Rodeo Association to issue licences and collect fees on all concession and business enterprises operated during, and on the grounds of the Annual Papago Fair, Livestock Show and Rodeo, at Sells Agency.

Section No. 7 REVOLVING FUND

All contributions, admission fees, concession fees, receipts from Association-operated amusement devices and concessions, entry fees and miscelleneous collections and receipts, shall be promptly deposited in the designated depositary, to the credit of the Association, and shall be available for expenditure under proper authorization of the Board of Directors, for carrying out the purposes of this ordinance.

Section No. 8 AUTHORITY FOR USE OF TRIBAL FUNDS

There is herby authorized to appropriated, out of any money in the Tribal Treasury not otherwise appropriated, such summs an maybe necessary for the purpose of carrying out the purposes of this ordinance, including the construction of suitable fair,

livestock show, and rodeo, facilities.

RESOLUTION OF THE PAPAGO TRIBE (Rodeo & Fair)

RES. NO. 37-79

WHEREAS, Ordinance Number 4 of the Papago Tribe, enacted by the Papago Council on January 7, 1939, authorized the Papago Fair and Rodeo Association, the affairs of which were to be managed by a Board of Directors, the members of which 4 were appointed by the Papago Council. 5

WHEREAS, the Ordinance states among other provisions, the powers 6 and duties of the Board of Directors to conduct annually 7 an event called the Papago Fair, Livestock Show, and Rodeo. 8 9 WHEREAS, Section 4(e) of the said Ordinance states: "The Treasurer of the Papago Fair and Rodeo Association shall accept, 10 receipt for, keep, and safeguard all funds of the As-11 sociation. He shall deposit all such funds in the name 12 of the Association, subject to his checking account, in a 13 bank insured by the Federal Deposit Insurance Corporation, 14 and located in Tucson, Arizona, to be selected by the 15 Board of Directors, and shall make and preserve a faithful 16 record of such funds and shall report on all receipts and 17 expenditures and the amount and nature of all funds in his 18 possession or custody, to the Board of Directors of the 19 Association, at meetings of the Board, or at such other 20 times as requested by the Board, his reports to be in 21 writing and matters of record. He shall give a satisfactory 22 23 surety bond to the Association in the Sum of \$2,000.00, 24 and shall not pay or otherwise disburse any funds in the 25 possession or custody of the Papago Fair and Rodeo Associ-26 ation except when properly authorized to do so by resolution 27 duly passed by the Board of Directors of the Association .. ' 28WHEREAS, Section 7 of said Ordinance states: "All contributions, 29 admission fees, concession fees, receipts from Association-30 operated amusement devices and concessions, entry fees, 31 and miscellaneous collections and receipts, shall be promptly 32 deposited in the designated depositary, to the credit of the

1 Association and shall be available for expenditure under 2 proper authorization of the Board of Directors, for 3 carrying out the purposes of this ordinance....." 4 WHEREAS, the Papago Rcdeo and Fair had been established by the 5 Papago Council as an activity of the Papago Tribe, wholly-6 owned and operated explicitly for the welfare, morals, and 7 benefits of the Papago people. That an activity duly 8 authorized and established as an entity of the Papago 9 Tribe of necessity must operate according to its Ordinances/ 10 Resolutions, to include accountability for funds, equipment 11 and other assets.

12 THEREFORE, BE IT RESOLVED that any and all funds on hand, on deposits 13 in seperate checking accounts and/or savings accounts or invested in any securities, bearing the names of the Papago 14 Fair and Rodeo Association, any member of its Board of 15 16 Director and/or Roedo and Fair, be immediately placed under 17 the custody of the Treasurer of the Papago Tribe. Further, 18 that any and all funds received incident to the annual 19 Papago Fair, Livestock Show, and Rodeo be promptly turned 20 into the Treasurer of the Papago Tribe for deposit to the 21 Tribal General Fund Checking Account, and that all funds 22 received by and administrative and operating expenses in-23 curred by or on behalf of the Papago Rodeo and Fair act-24 ivity be accounted for by the Tribal Treasurer in the same 25 manner as for other Tribal-owned funds. That, the pro-26 visions of this Resolution are controlling where they 27 contravene any Ordinances/Resolutions enacted by the Papago 28 Council, those affecting fund management and accountability 29 by Rodeo and Fair activity, Fair and Rodeo Association, 30 and/or its Board of Directors.
